Office of the Official Opposition Proposed Legislative Agenda for Emergency Sitting May 22 2020

An Act to Amend the Audit Act (Follow the Dollar) *(consultation draft provided)* Sponsor: Michele Beaton

- Empowers the Auditor General to audit third-party organizations that receive government funds or provide services on behalf of government
- Expands reporting, allowing the AG to report multiple times during the year and issue special reports

An Act to Amend the Rental of Residential Property Act *(consultation draft provided)* Sponsor: Hannah Bell

- Addresses tenant issues and concerns related to pandemic, including
 - Allowing a lessor (landlord) to reasonably restrict or limit access to common areas during a state of public health emergency or a state of emergency.
 - Allowing the Director of Residential Rental Property to issue an order suspending the service of eviction notices
 - Allowing the Director to issue an order to increase the time available to lessees (tenants) to make an application to set aside a notice of termination of a lease.
 - Prohibiting the personal delivery of documents where a state of public health emergency exists and doing so would not reasonably be in accordance with an order or guideline issued by the Chief Public Health Officer.

An Act to Amend the Employment Standards Act (4) Sponsor: Peter Bevan-Baker

• Amend the *Employment Standards Act* to include whistleblower protection for employees reporting an offence. This is separate from the government legislation, which introduces an unpaid emergency leave.

An Act to Amend the Emergency Measures Act (2) Sponsor: Peter Bevan-Baker

- Provides accountability mechanisms within the *Emergency Measures Act*. Under the amendments:
 - The Legislative Assembly could vote to disallow a declaration of a state of emergency;
 - Cabinet could only renew a state of emergency for one additional period of 14 days, after which the Legislative Assembly would have to approve subsequent renewals of no more than 28 days each.
 - Following the end of a state of emergency, the Minister would be required to submit a report to the Legislative Assembly detailing the reasons necessitating the declaration of a state of emergency, the powers exercised during state of emergency (including the powers under government's bill), and other details that the Minister considers necessary.
 - There would be greater clarity around privacy considerations under the EMA.

Proposed Amendments to Government Bills

We will also be bringing our amendments forward on the floor during debate of the Government bills, *An Act to Amend the Emergency Measures Act* and *An Act to Amend the Public Health Act*. Provisions in these bills give government extraordinary powers to suspend or vary the application or operation of provincial enactments. Our amendments would create more stringent preconditions for these powers to be used.

Finally, we are looking at incorporating provisions that would empower the Legislative Assembly to disallow or modify an order by Cabinet exercising these powers. As these pieces of legislation allow government to partially assume the legislative capacity of the Legislative Assembly, it is important that the Legislative Assembly is able to reconsider these orders.
