## AN ACT TO AMEND THE PRINCE EDWARD ISLAND LANDS PROTECTION ACT (NO. 2)

**BILL NO. 102**

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1. **Section 12 of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap L-5, is amended**
  - (a) **in clause (5)(b), by the deletion of the words “where the investigation was directed by the Minister under subsection (1),”;** **and**
  - (b) **by the addition of the following after subsection (5):**

**Report to be laid before Legislative Assembly**

- (5.1) The Minister shall cause the full report of an investigator and supporting documents received under clause (5)(b) to be laid before the Legislative Assembly if then in session or, if the Legislative Assembly is not then in session, within fifteen days of the opening of the next ensuing session.

**EXPLANATORY NOTES**

**SECTION 1** amends section 12 of the *Prince Edward Island Lands Protection Act*

- (a) to remove the application of the requirement that an investigation must have been one directed by the responsible Minister, for a report of an investigator and supporting documents to be provided to the Minister; and
- (b) to require the Minister to lay a copy of a report of an investigator and supporting documents provided to the Minister by the Island Regulatory and Appeals Commission as required under clause 12(5)(b) of the Act, before the Legislative Assembly.
