AN ACT TO AMEND THE PETROLEUM PRODUCTS ACT

BILL NO. 109

2026

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1. Section 31 of the *Petroleum Products Act* R.S.P.E.I. 1988, Cap. P-5.1, is amended
 - (a) by the deletion of the words “In determining” and the substitution of the words “Subject to subsection (2), in determining”;
 - (b) by renumbering it as subsection (1); and
 - (c) by the addition of the following after subsection (1):

New York Harbor benchmark
- (2) In determining the maximum price of heating fuel or motor fuel, the Commission shall base the wholesale benchmark price on the New York Harbor benchmark.

EXPLANATORY NOTES

SECTION 1 amends section 31 of the *Petroleum Products Act* by renumbering it as subsection (1) and adding a subsection (2) that requires the Commission to use the New York Harbor benchmark as the wholesale benchmark price when determining the maximum price of heating fuel or motor fuel.
