AN ACT TO AMEND THE LIQUOR CONTROL ACT (NO. 2)

BILL NO. 116 2024

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1 The *Liquor Control Act* R.S.P.E.I. 1988, Cap. L-14, is amended by the addition of the following after section 88:

88.1 Expenditures for liquor consumption programs

Notwithstanding anything contained in this Act or any other enactment, for each fiscal year, the Commission shall allocate an amount that is not less than three percent of its anticipated net profits for the initiatives and programs referred to in clause 88(b).

2. Appropriation required

The moneys required for the purpose of this Act shall be paid out of moneys appropriated for that purpose by the Legislature.

EXPLANATORY NOTES

SECTION 1 amends the *Liquor Control Act* to require that, for each fiscal year, the Commission allocate an amount that is not less than three percent of its anticipated net profits to conduct or support initiatives and programs that promote responsible liquor consumption and warn of the harm caused by irresponsible liquor consumption.

SECTION 2 provides that the moneys required for the purpose of this Act will be paid out of moneys appropriated for that purpose by the Legislature.
