#### AN ACT TO AMEND THE REAL PROPERTY ASSESSMENT ACT

BILL NO. 67 2024

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

- 1. (1) Subsection 1(3) of the *Real Property Assessment Act* R.S.P.E.I. 1988, Cap. R-4, is amended by the addition of the words "on or before December 31, 2024," after the words "of this Act,".
- (2) Section 1 of the Act is amended by the addition of the following after subsection (3):
  - Owner-occupied residential property, January 1, 2025, and after
- (3.1) For the purposes of this Act, on and after January 1, 2025, real property that is assessed as residential property in a person's name during a calendar year is "owner-occupied residential property" in respect of all or part of the calendar year, if that person
  - (a) owned and occupied the residential property; and
  - (b) did not lease or rent any part of the residential property for a period of less than 30 days during that calendar year.

#### **EXPLANATORY NOTES**

**SECTION 1** amends subsection 1(3) of the *Real Property Assessment Act* R.S.P.E.I. 1988, Cap. R-4, to limit the definition of "owner-occupied residential property" to the period prior to December 31, 2024. The section also amends section 1 of the Act by adding a new subsection (3.1) that modifies the definition of "owner-occupied residential property" for the period on and after January 1, 2025.
