## AN ACT TO AMEND THE PLANT HEALTH ACT

BILL NO. 86

2022

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

- 1. Subsection 3(5) of the *Plant Health Act* R.S.P.E.I. 1988, Cap. P-9.1, is amended
  - (a) in clause (c), by the deletion of the period and the substitution of a semicolon; and
  - (b) by the addition of the following after clause (c):
  - (d) order that a boundary determined by the Minister be established and demarcated around an area on a farm unit where a regulated disease or causal pathogen has been detected;
  - (e) prohibit or restrict the planting of any crop or particular crops within a bounded area established pursuant to clause (d), for a period not exceeding 20 years from the date of detection;
  - (f) prohibit or restrict the planting of any crop or particular crops within a bounded area established pursuant to clause (d) or on the farm unit, unless specified conditions are met, which may include the submission of a management plan for crops and soil and the approval of the Minister; or
  - (g) make any other order authorized by the regulations to mitigate or eliminate the hazard.
- 2. Section 3.3 of the Act is amendment by the addition of the words "or causal pathogen" after the words "any regulated disease".

## **EXPLANATORY NOTES**

**SECTION 1** amends section 3 of the Act to set out other remedies the Minister may order to mitigate or eliminate a hazard caused by a regulated disease or causal pathogen.

**SECTION 2** amends section 3.3 of the Act to provide for its application where there is a reasonable belief of the existence of a regulated disease or causal pathogen.
