AN ACT TO AMEND THE HEALTH AND DENTAL SERVICES COST ASSISTANCE ACT

BILL NO. 50 2024

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

- 1. Section 1 of the *Health and Dental Services Cost Assistance Act* R.S.P.E.I. 1988, Cap. H-1.21, is amended
 - (a) in clause (a), by the addition of the words ", except where otherwise specified" after the word "program";
 - (b) in clause (d), by the addition of the words ", except where otherwise specified" after the word "program"; and
 - (c) in clause (k), by the addition of the words ", except where otherwise specified" after the word "Plan".
- 2. Subsection 4(1) of the Act is repealed and the following substituted:
- 4. Payor of last resort
- (1) Where, in respect of a benefit, an eligible person is covered by third-party insurance or a prescribed benefit plan or program not established under this Act, the Plan shall be the payor of last resort.
- 3. Section 6 of the Act is amended by the deletion of the words "A person is not eligible" and the substitution of the words "Except where otherwise provided in regulations, a person is not eligible".
- 4. Section 19 of the Act is amended by the addition of the following after clause (b):
 - (b.1) prescribing a benefit plan or program not established under this Act for the purpose of subsection 4(1);

EXPLANATORY NOTES

SECTION 1 amends the definitions of "administrator", "claim" and "program" to provide for their use in reference to coverage for benefits under third-party insurance or a plan or program not established under the Act.

SECTION 2 repeals and replaces subsection 4(1) of the Act to establish the Plan as the payor of last resort in respect of a benefit for which an eligible person is covered by third-party insurance or a prescribed benefit plan or program not established under the Act.

SECTION 3 amends section 6 of the Act to reflect that the regulations may coordinate benefits between the Plan and a prescribed benefit plan or program not established under the Act.

SECTION 4 adds a regulation-making power to section 19 of the Act for the purpose of the new subsection 4(1).
