AN ACT TO AMEND THE FINANCIAL ADMINISTRATION ACT (NO. 2)

BILL NO. 26

2023

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

- 1. Clause 1(q) of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9, is amended by the deletion of the word “his” and the substitution of the words “the Minister’s or public officer’s”.**
- 2. Subsection 30(2) of the Act is amended by the deletion of the word “he” and the substitution of the words “the Minister”.**
- 3. Subsection 32(3) of the Act is amended by the deletion of the word “he” wherever it occurs and the substitution of the words “the Minister”.**
- 4. (1) Subsection 39(1) of the Act is amended by the deletion of the word “him” and the substitution of the words “that Minister”.**
(2) Clauses 39(3)(a) and (c) of the Act are amended by the deletion of the word “his” and the substitution of the words “the Comptroller’s”.
- 5. Section 40 of the Act is amended in the words immediately preceding clause (a) by the deletion of the word “him” and the substitution of the words “that Minister”.**
- 6. Subsection 60(1) of the Act is amended in the words after clause (e) by the deletion of the word “he” and the substitution of the words “the Comptroller”.**
- 7. Section 62 of the Act is amended by the deletion of the word “his” and the substitution of the words “the Comptroller’s”.**
- 8. (1) Clause 65(3)(b) of the Act is amended by the deletion of the word “his” and the substitution of the words “the auditor’s”.**

(2) Subsection 65(4) of the Act is amended by the deletion of the word “he” and the substitution of the words “the Auditor General”.

9. Subsection 70(5) of the Act is amended

(a) in the words immediately preceding clause (a), by the deletion of the words “in such form as he may require” and the substitution of the words “in the form required by the Minister”; and

(b) in clause (a),

(i) by the deletion of the word “he” and the substitution of the words “the Minister”, and

(ii) by the addition of the word “and” after the semicolon.

10. (1) Subsection 71(1) of the Act is amended

(a) by the deletion of the word “Auditor” wherever it occurs and the substitution of the words “Auditor General”;

(b) by the deletion of the words “his or her” wherever they occur and the substitution of the words “Auditor General’s”; and

(c) by the deletion of the words “Auditor’s opinion” and the substitution of the words “Auditor General’s opinion”.

(2) Subsection 71(2) of the Act is amended by the deletion of the word “auditor” and the substitution of the words “Auditor General”.

(3) Subsection 71(3) of the Act is amended by the deletion of the word “auditor” and the substitution of the words “Auditor General”.

11. Clause 75(1)(b) of the Act is amended by the deletion of the word “he” and the substitution of the words “the person”.

12. Section 76 of the Act is amended

(a) in clause (d), by the deletion of the word “his” and the substitution of the words “the person’s”; and

(b) in the words after clause (f), by the deletion of the word “his” and the substitution of the words “the person’s”.

13. **Section 77 of the Act is amended by the deletion of the words “in connection with his employment by any person” and the substitution of the words “by a person in connection with the person’s employment”.**

14. **Schedule A and Schedule B to the Act are repealed and Schedule A and Schedule B as set out in the Schedule to this Act are substituted.**

EXPLANATORY NOTES

SECTION 1 amends clause 1(q) of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9, to substitute gender-neutral wording.

SECTION 2 amends subsection 30(2) of the Act to substitute gender-neutral wording.

SECTION 3 amends subsection 32(3) of the Act to substitute gender-neutral wording.

SECTION 4 amends subsection 39(1) and clauses 39(3)(a) and (c) of the Act to substitute gender-neutral wording.

SECTION 5 amends section 40 of the Act to substitute gender-neutral wording.

SECTION 6 amends subsection 60(1) of the Act to substitute gender-neutral wording.

SECTION 7 amends section 62 of the Act to substitute gender-neutral wording.

SECTION 8 amends clause 65(3)(b) and subsection 65(4) of the Act to substitute gender-neutral wording.

SECTION 9 amends subsection 70(5) of the Act to substitute gender-neutral wording and to correct a typographical error.

SECTION 10 amends section 71 of the Act to substitute gender-neutral wording and clarify references throughout to the Auditor General.

SECTION 11 amends clause 75(1)(b) of the Act to substitute gender-neutral wording.

SECTION 12 amends clauses 76(d) and (f) of the Act to substitute gender-neutral wording.

SECTION 13 amends section 77 of the Act to substitute gender-neutral wording and clarify the wording.

SECTION 14 repeals Schedule A and Schedule B to the Act and substitutes a new Schedule A that contains the updated names of the Government Departments and other entities, and a new Schedule B that contains the corrected names of the reporting entities in alphabetical order.
