## AN ACT TO AMEND THE CHILD, YOUTH AND FAMILY SERVICES ACT

BILL NO. 60

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1. The *Child, Youth and Family Services Act* S.P.E.I. 2023, c. 17, is amended by the addition of the following after section 78:

**78.1 Repeal**

The *Child Protection Act* R.S.P.E.I. 1988, Cap. C-5.1, is repealed.

### EXPLANATORY NOTES

**SECTION 1** amends the *Child, Youth and Family Services Act* to add section 78.1, which repeals the legislation it is replacing: the *Child Protection Act*. This provision was unintentionally omitted from the original bill.
