## AN ACT TO AMEND THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT

**BILL NO. 125**

**2022**

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1. **Clause 1(h) of the *Freedom of Information and Protection of Privacy Act* R.S.P.E.I. 1988, Cap. O-5.1, is repealed and the following substituted:**
  - (h) **“officer of the Legislative Assembly”** means any person appointed as an officer of the Legislative Assembly by the Legislative Assembly;

**EXPLANATORY NOTES**

**SECTION 1** amends the *Freedom of Information and Protection of Privacy Act* to replace the definition of “officer of the Legislative Assembly” with a more general definition that will capture both current officers and those officers that may be provided for in future legislation.
