AN ACT TO AMEND THE FINANCIAL ADMINISTRATION ACT

BILL NO. 15 2023

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

1. Subsections 61(1.1) and (1.2) of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9, are repealed and the following substituted:

Submission of Public Accounts to Legislative Assembly

- (1.1) The Minister shall file the Public Accounts prepared by the Comptroller for a fiscal year with the Clerk of the Legislative Assembly on or before September 30 next following the end of that fiscal year.
- 2. This Act comes into force on January 1, 2024.

EXPLANATORY NOTES

SECTION 1 repeals subsections 61(1.1) and (1.2) of the Act and substitutes a new subsection (1.1) to change the date on or before which the Minister is required to file the Public Accounts for a fiscal year with the Clerk of the Legislative Assembly to September 30 next following the end of that fiscal year, regardless of whether there is a fixed-date election to be held in the month of October next following the end of that fiscal year.

SECTION 2 provides for the commencement of this Act.
