## AN ACT TO AMEND THE PHARMACY ACT

BILL NO. 62

2024

BE IT ENACTED by the Lieutenant Governor and the Legislative Assembly of the Province of Prince Edward Island as follows:

- 1. Section 1 of the *Pharmacy Act* R.S.P.E.I. 1988, Cap. P-6.1, is amended
  - (a) in clause (cc), by the deletion of the period and the substitution of a semicolon; and
  - (b) by the addition of the following after clause (cc):
  - (dd) "unscheduled drug" means
    - (i) subject to the regulations, a drug that is not listed in Schedule I, II or III of the National Drug Schedules, and
    - (ii) a drug designated in the regulations as an unscheduled drug.
- 2. Section 22 of the Act is amended
  - (a) in clause (b), by the addition of the words "an unscheduled drug," after the words "National Drug Schedules as"; and
  - (b) in clause (c), by the addition of the words ", a Schedule III drug or an unscheduled drug" after the words "Schedule I drug".
- **3.** Subsection 51(1) of the Act is amended
  - (a) in clause (i), by the addition of the words "an unscheduled drug," after the words "National Drug Schedules as"; and
  - (b) in clause (j), by the addition of the words ", a Schedule III drug or an unscheduled drug" after the words "Schedule I drug".

### **EXPLANATORY NOTES**

SECTION 1 amends section 1 of the Act to add a definition of the term "unscheduled drug".

SECTION 2 amends section 22 of the Act to provide for

- a drug listed in Schedule III of the National Drug Schedules to be designated in the regulations as an unscheduled drug, a Schedule II drug or a Schedule I drug; and
- a drug listed in Schedule II of the National Drug Schedules to be designated in the regulations as a Schedule I drug, a Schedule III drug or an unscheduled drug.

**SECTION 3** amends subsection 51(1) of the Act to update the regulation-making powers that correspond with the amendments to section 22 of the Act.
